उक्त प्रशिक्षण का समय प्रातः 09:30 से सायं 06:00 बजे तक रहेगा। यह प्रशिक्षण पूर्णतः गैर आवासीय है, अतः प्रशिक्षणार्थी को आवास व खान-पान आदि की व्यवस्था स्वयं के स्तर पर करनी होगी तथा प्रशिक्षण अवधि आठ सप्ताह (सात सप्ताह का संस्थानिक प्रशिक्षण व एक सप्ताह का परीक्षा कार्यक्रम) की होगी। उक्त प्रशिक्षण अवधि में सभी प्रशिक्षणार्थियों को वेतन एवं भत्ते आदि का भुगतान उनके वर्तमान पदस्थापन कार्यालय द्वारा ही किया जायेगा।

उपरोक्त सभी कनिष्ठ लेखाकारों को राजस्थान अधीनस्थ लेखा सेवा नियम 1963 के नियम 32(2) के अनुसार प्रशिक्षण प्राप्त कर विभागीय परीक्षा उत्तीर्ण करना अनिवार्य है। अतः सम्बन्धित कार्यालयाध्यक्ष/विभागाध्यक्ष से अनुरोध है कि वे उनके कार्यालय/विभाग में कार्यरत उपरोक्त समस्त कनिष्ठ लेखाकारों को प्रशिक्षण हेतु आवश्यक रूप से कार्यमुक्त करें। किसी भी कनिष्ठ लेखाकार को प्रशिक्षण से मुक्त रखना संभव नहीं होगा।

यदि कोई कनिष्ठ लेखाकार प्रशिक्षण अवधि में या प्रशिक्षण अवधि की समाप्ति के एक वर्ष की अवधि में राजस्थान अधीनस्थ लेखा सेवा से त्यागपत्र देना चाहेगा अथवा अन्य पद ग्रहण करना चाहेगा तो ऐसी स्थिति में उन्हें प्रशिक्षण अवधि में उसके द्वारा प्राप्त समस्त प्रकार के वेतन-भत्ते तथा प्रशिक्षण पर हुए व्यय की दो गुना राशि का भुगतान एकमुश्त राजकोष में जमा कराना आवश्यक होगा। सभी प्रशिक्षणार्थी प्रशिक्षण पर उपस्थिति देते ही निर्धारित प्रपत्र (संलग्न) में बाण्ड भरकर सम्बन्धित पाठ्यक्रम निदेशक को प्रस्तुत करेंगे।

प्रशिक्षण की समाप्ति उपरान्त उपरोक्त सभी कनिष्ठ लेखाकार अपने वर्तमान पदस्थापन कार्यालय में ही उपस्थिति देंगे।

This bond is made on the _____ date of 2017 by _____ Son of Shri _____ resident of _____ appointed to the post of ACCOUNTANT/JUNIOR ACCOUNTANT (hereinafter called the trainee) of the First Part and _____ Son of Shri _____ resident of _____ (First Surety); and _____ Son of Shri _____ resident of _____ (Second surety) hereinafter called collectively the sureties of the second part in favour of the Governor of the State of Rajasthan (hereinafter called the Government).

Whereas the Governor has selected the trainee for appointment to the post of ACCOUNTANT/JUNIOR ACCOUNTANT.

And whereas in accordance with Rules it is necessary for the trainee, before assuming independent charge of the post for which he has been also selected to undergo training for a period of _____ weeks.

And whereas the Government have agreed to place the trainee under training on the terms hereinafter mentioned and on the condition that the sureties shall give security for the due performance by the trainee of the said terms.

And whereas the sureties have agreed to give security for the due performance by the trainee of the said terms in the manner hereinafter after appearing.

Now this deed witnesses as follows:-

(1) In consideration of the Government selecting the trainee for appointment to the post of ACCOUNTANT/JUNIOR ACCOUNTANT and arranging for his training in accordance with the Rules, and in pursuance of the said agreement, the trainee hereby covenants with the Government that during the period of such training and within a period of 01 year after the completion of such training, he shall not resign the post for which he has been selected as aforesaid, nor shall he take up any employment other than post for which he has been so selected.

(2) For the consideration aforesaid in pursuance of the said agreement the trainee and the sureties agree that if, during the period of training or within a period of 01 year after the completion of training, the trainee shall resign or take other employment in contravention of clause (1) above, the trainee and the sureties shall jointly and severally pay to the Government the double of the emoluments paid by the Government to the trainee during the period of his training together with other expenses incurred by the Government thereon but excluding the amounts paid to the trainee by way of traveling and daily allowances under the relevant rules.

Provided that the trainee and the Parties shall not be required so to pay the emoluments paid to the trainee during the period of his training, if the training imparted to the trainee, in the opinion of the Government, likely to provide useful in the new appointment also.
